(c) acknowledges that the GFBF shall not be responsible for any injury to the Participant, including death or any loss or injury to property or person, suffered by the Participant at any time as a result of the Participant's Attendance at the Young Adult Retreat, whether such injury is foreseeable or not including those arising from the breach of any statutory of other duty of care or negligence of the GFBF; and
(d) agrees not to commons proceedings against the CERE with respect to any and all claims, actions

- agrees to indemnify and save and hold harmless the GFBF and its officers, directors, members, volunteers, partners, associates, employees, agents, successors and assigns from any and all claims, actions, causes of action, damages, debts and demands, in law or equity, including those arising from negligence or the breach of any statutory or other duty of care, and whether actual, potential, known or unknown, anticipated or potential, arising from or in relation to, based on, or connected to the Participant's Attendance at the Young Adult Retreat including claims, actions, causes of action, damages, debts and demands, in law or equity, including those arising from negligence or the breach of any statutory or other duty of care, and whether actual, potential, known or unknown anticipated or potential, arising from or in relation to based on or connected to the Participants' attendance at the Young Adult Retreat, including his or her travel to and from the Young Adult Burn Survivor Retreat.

The undersigned agrees that if any portion of this document is held to be invalid, that the balance of the document shall, notwithstanding, continue in full legal force and effect. The undersigned agrees that this document be governed by and interpreted in accordance with the laws of Georgia. The undersigned confirms that he or she has read and understood the terms of this document and agrees to be bound thereby. The undersigned further acknowledges that he or she has had the opportunity to receive legal advice before signing this document and that he or she had signed this document freely and voluntarily and without any duress or undue influence on the part of any person.
